**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF GROCERY
PACKS FOR THE CAAP-GPR AIRPORT 2023 CHRISTMAS PARTY**

WHEREAS, BAC Resolution No. BSVP 2023-067-01 for the project **Supply and Delivery of Grocery Packs for the CAAP-GPR Airport 2023 Christmas Party** with Approved Budget for the Contract (ABC) in the amount of **Fifty Thousand Pesos (₱ 50,000.00)** for hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 22, 2023, **ILOILO SUPERMART INC.** was declared Single Calculated Bid with the Bid amount of **Forty Nine Thousand Nine Hundred Ninety Eight Pesos & 75/100 (₱49,998.75)**;




