**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
AND RECOMMENDING APPROVAL OF REPAIR AND UPGRADING OF LAPTOP

**WHEREAS**, BAC Resolution No. BSVP 2023-068-01 for the project **Repair and Upgrading of Laptop and Desktop Computers of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Fifty Four Thousand Nine Hundred Ninety Pesos (₱ 154,990.00)** for hereby form the integral part of this resolution. **WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, One (1) interested supplier submitted its sealed quotation;

**WHEREAS**, during the Bid Opening last December 27, 2023, **CYBER LINK COMPU SALES** was declared Single Calculated Bid with the Bid amount of **One Hundred Fifty Four Thousand Nine Hundred Sixty Pesos (₱ 154,960.00)**;
