**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF PURCHASE OF FIRECRACKERS FOR
DEC. 2023 – JAN. 2024 OF ARFF AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-069-01 for the project **Purchase of Firecrackers for Dec. 2023 – Jan. 2024 of ARFF at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Forty Nine Thousand Four Hundred Pesos (₱ 49,400.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last December 13, 2023, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Bid with the Bid amount of **Forty Nine Thousand Four Hundred Pesos (₱ 49,400.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
