**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE-BID AND  
RECOMMENDING APPROVAL FOR THE SUPPLY AND DELIVERY OF  
JANITORIAL SUPPLIES FOR THE MONTH OF OCTOBER TO DECEMBER 2023  
OF ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Supply and Delivery of Janitorial Supplies for the month of October to December 2023 of Iloilo International Airport** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Three Million Four Hundred Ninety Seven Thousand Forty Five Pesos (P 3,497,045.00)**;

**WHEREAS**, in response to the said advertisement, Four (4) interested bidders submitted its letter of intent and bought the bidding documents;

**WHEREAS**, on the day of the Preliminary Examination of Bids, Four (4) bidders submitted their sealed bid proposals;

**WHEREAS**, during the Bid Opening last October 31, 2023, **PHILIPPINE VISION GROUP (PVG) INC.** was declared Lowest Calculated Bid with the Bid amount **One Million Nine Hundred Sixty One Thousand Seven Hundred Twenty Pesos (P 1,961,720.00)**;

**WHEREAS**, bid submitted by **NEWTOWN MERCHANDISING INC.** has been disqualified during the bid opening due to: as per submitted Omnibus Sworn Statement, Joanne T. Foo, General Manager, was designated as authorized representative, meanwhile, in your attached notarized Secretary Certificate, Eleonor S. Cerami was the duly appointed authorized representative by the Corporate Secretary to do, execute and perform any and all acts necessary and/or to represent Newtown Merchandising Inc. in the bidding.

In Section 25.3a of the 2016 revised IRR of RA No. 9184 states that *“The signatory is the duly authorized representative of the prospective bidder, and granted full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract accompanied by the duly notarized Special Power of Attorney, Board/Partnership Resolution, or Secretary’s Certificate, whichever applicable.”*

**WHEREAS**, the price quotations of the bidders was found to be substantially complying:




