



**Contract Agreement Form for the
 Procurement of Infrastructure Projects (Revised)**

THIS AGREEMENT, made on DEC 27 2023 between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI** of Davao City, Philippines (hereinafter called "the Entity") and **NIRVANA CONSTRUCTION & SUPPLIES** of Koronadal City, South Cotabato, Philippines (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "**COTABATO AIRPORT DEVELOPMENT PROJECT (IMPROVEMENT OF LANDSIDE AREA AND AIRSIDE AREA)**" under **Purchase Request No. 23-07-052** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION SIX HUNDRED FIFTY-ONE THOUSAND ONE HUNDRED EIGHTY-FIVE PESOS AND FOUR (04/100) CENTAVOS ONLY (₱ 2,651,185.04)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- A. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - vi. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

- B. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- C. Performance Security;

- D. Notice of Award of Contract and the Bidder's conforme thereto; and

In consideration for the sum of **TWO MILLION SIX HUNDRED FIFTY-ONE THOUSAND ONE HUNDRED EIGHTY-FIVE PESOS AND FOUR (04/100) CENTAVOS ONLY (₱ 2,651,185.04)**, **NIRVANA CONSTRUCTION & SUPPLIES agrees to implement and complete the project, "COTABATO AIRPORT DEVELOPMENT PROJECT (IMPROVEMENT OF LANDSIDE AREA AND AIRSIDE AREA)"** in accordance with his/her/its Bid.

4. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


