Ladies and Gentlemen:

In connection with the contract, "**REMOVAL OF RUBBER DEPOSITS AT GENSAN**", which was awarded to your end by this office with the contract price of **FIVE MILLION THREE HUNDRED SEVENTY-THREE THOUSAND FIFTY-SEVEN PESOS AND SIXTY-ONE CENTAVOS (61/100) ONLY (P 5,373,057.61)**, you are hereby **notified to proceed** and to commence the said contract within seven (7) calendar days upon the date of this notice with the following conditions:

1. That you shall completely undertake the said works within **SEVENTY-THREE (73) calendar days** without hampering the smooth regular operation of the airport;
2. That you shall coordinate with the CAAP-Project-In-Charge prior to commencement of work;
3. That you shall abide with the policies of the airport when entering restricted area/s;
4. That you shall submit list of the personnel who will perform the said tasks;
5. That the personnel who will perform the task **MUST wear UNIFORM or WORKING CLOTHES** while working at the area;
6. That all your laborers are required to have a temporary ACCESS PASS prior to their deployment;
7. That you have to maintain the cleanliness within the work-place during and after the day's work;
8. That you shall display Safety signs and Work/Activity-advisory at the area where appropriate;
9. That all your workers shall always wear protective clothing & equipped with personal protective equipment while working in the interest of safety;
10. That you shall be monitored by the CAAP Technical Staff during the duration of the project; AND
11. That you shall submit a certificate of completed work which shall be evaluated by the CAAP's Technical Staff prior to payment of your services.


