



**Contract Agreement Form for the
 Procurement of Civil Works/Infrastructure Projects (Revised)**

THIS AGREEMENT, made on _____ between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI** of Davao City, Philippines (hereinafter called "the Entity") and **NIRVANA CONSTRUCTION & SUPPLIES** of Koronadal City, South Cotabato, Philippines (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "REPLACEMENT OF 1-UNIT DEEPWELL 25HP SUBMERSIBLE MOTOR AND PUMP" under Purchase Request No. 2023-07-196 (hereinafter called "the Works") and the Entity has accepted the Bid for **ONE MILLION THREE HUNDRED FIFTY-EIGHT THOUSAND NINE HUNDRED TWENTY-NINE PESOS AND FIFTY-SIX (56/100) CENTAVOS ONLY (₱ 1,358,929.56)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - vi. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- B. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- C. Performance Security;
- D. Notice of Award of Contract and the Bidder's conforme thereto; and
- E. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are**


