PROCUREMENT OF THE 1 LOT SUPPLY AND DELIVERY FOR THE CONTRACT:
"SPAREPARTS FOR MONITOR TRANSPONDER UNIT (MTU) AND RECEIVER UNIT (RXU)"
 THROUGH DIRECT CONTRACTING

THIS AGREEMENT made on DEC 30 2023 between **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI of Davao City, Philippines** (hereinafter called "the Entity") of the one part and **INDRA PHILIPPINES, INC. of Pasig City, Philippines** (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity requested the Supplier, being the *exclusive distributor of Indra products in the Philippines*, to submit their quotation for certain goods and ancillary services, viz., **"SPAREPARTS FOR MONITOR TRANSPONDER UNIT (MTU) AND RECEIVER UNIT (RXU)"** for **CAAP- Davao City** and has accepted the quotation by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SEVEN HUNDRED SIXTY-THREE THOUSAND NINETY-FIVE PESOS AND THIRTY-NINE CENTAVOS (39/100) ONLY (₱ 1,763,095.39)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- e) the Terms and Conditions;
- f) the Performance and/or Warranty Security;
- g) the Entity's Notice of Award; and
- h) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQs. **Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as Purchase Order and Variation Orders shall likewise form part of the Contract.**

In consideration for the sum of ONE MILLION SEVEN HUNDRED SIXTY-THREE THOUSAND NINETY-FIVE PESOS AND THIRTY-NINE CENTAVOS (39/100) ONLY (₱ 1,763,095.39) **INDRA PHILIPPINES, INC. agrees to supply and deliver the Spare Parts For Monitor Transponder Unit (MTU) And Receiver Unit (RXU)** in accordance with his/her/its quotation.






