Dear Mr. Co:

Pursuant to Republic Act No. 9497, Section 68 (b), in compliance with the Civil Aviation Regulations governing Aerodromes (CAR-Aerodromes) requirements for aerodromes used for international civil aviation to be certified, being compliant with the CAAP standards for certified aerodromes, an AERODROME CERTIFICATE has been granted by the Director General to Ninoy Aquino International Airport (NAIA) located at Pasay City, Metro Manila.

Under the requirements of the Civil Aviation Authority of the Philippines (CAAP) on its aerodrome surveillance program, your aerodrome will be subject to surveillance and routine inspection by the Aerodrome and Air Navigation Safety Oversight Office (AANSOO), CAAP.

To ensure that compliances are monitored and the level of safety is not compromised, NAIA must:

1. Strictly adhere to the Terms and Conditions (Annex A) attached to the Aerodrome Certificate;
2. Update and publish on time all changes to its Aeronautical data in the Aeronautical Information Publication;
3. Continuously work to address the remaining non-conformances with the aerodrome standards; and
4. Submit to CAAP the remaining Charts related to the Aerodrome.
