**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF PRINTERS,
LAMINATING MACHINE AND SOUND LEVEL METER OF ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2024-002-01 for the project **Supply and Delivery of Printers, Laminating Machine and Sound Level Meter of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Twenty Five Thousand Seven Hundred Twenty Five Pesos (P125,725.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last February 5, 2024, **CYBERLINK COMPU SALES CORP.** was declared Single Calculated Bid with the Bid amount of **One Hundred Twelve Thousand Four Hundred Five Pesos (P112,405.00)**;

WHEREAS, bid submitted by **CP PAR-LAY INTERNATIONAL CORP.** has been disqualified during the bid opening due to: failure to attach the *Annual Income Tax Return, Omnibus Sworn Statement and Special Power of Attorney for Sole Proprietorship/Secretary Certificate for Corporation or Cooperative* as stated in the Request for Quotation;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
