MEMORANDUM CIRCULAR NO. 005 - 2024

TO : ALL PILOTS, AOC HOLDERS, ATOC HOLDERS AND ALL CONCERNED

SUBJECT: NEW FORMAT OF TEMPORARY AIRMAN LICENSE

DATE : 31 January 2024

Please take note of the new format for the Temporary Airman License that will be issued by the Civil Aviation Authority of the Philippines (CAAP) to eligible pilots, flight instructors, ground instructors, and other airmen who meet the requirements under PCAR Part 2 - Personnel Licensing. This temporary license will be **valid** for a maximum of **90 days** while the permanent license is being processed for printing.

The Temporary Airman License will be issued promptly, provided that the applicant fulfills all relevant regulatory requirements and pays the appropriate license fee. Once issued, the license will be considered valid and effective from the date of issuance, and the holder can immediately start performing activities allowed under the license. It is important to note that the holder of the license will be deemed compliant with the provisions of PCAR Part 1, Subsection 1.2.1.1, to wit:

1.2.1.1 Display and Inspection of Licenses and Certificates

(a) Pilot license:

(1) To act as a pilot of a civil aircraft of Republic of the Philippines registry, **a pilot shall have in his or her physical possession or readily accessible in the aircraft a valid pilot license or special purpose authorization** issued under these regulations. (Italics and emphasis supplied)

We have also attached a sample Temporary Airman License for your reference. Please carefully review the issuance conditions listed on the reverse side to avoid misunderstanding.

This new measure has been implemented to provide applicants with a seamless experience and enable them to immediately exercise the privileges attached to their licenses.

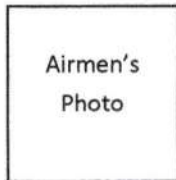

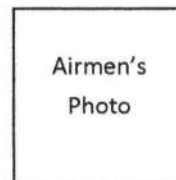
