WHEREAS, BAC Resolution No. BSVP-ILO 2024-012-01 for the project **Fire Prevention Awareness 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Twenty Thousand Pesos (₱ 20,000.00)** hereby form the integral part of this resolution.
