RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF RENOVATION OF STAFF HOUSE AND REPAIR OF ROOF OF PMO BUILDING AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-013-01 for the project **Renovation of Staff House and Repair of Roof of PMO Building at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Four Hundred Eighty Five Thousand One Hundred Nineteen Pesos & 86/100 (₱ 485,119.86)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last April 4, 2024, **EAJ CONSTRUCTION AND SUPPLY** was declared Single Calculated Bid with the Bid amount of **Four Hundred Eighty Four Thousand Five Hundred Twenty Four Pesos & 18/100 (₱ 484,524.18)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
