## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF PURCHASE OF PRINTER OF COLLECTION DEPARTMENT FOR ISSUANCE OF OFFICIAL RECEIPTS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-015-01 for the project Purchase of Printer of Collection Department for Issuance of Official Receipts at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Twenty Thousand Six Hundred Pesos (P20,600.00) hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last April 12, 2024, CYBERLINK COMPU SALES CORPORATION was declared Single Calculated Quotation with the Bid amount of Twenty Thousand Five Hundred Eighty Pesos (**P20,580.00**);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
