- Mayor's or Business Permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas;
- 2. Income Business Tax Return for ABC's above P500,000.00;
- 3. PHILGEPS Certificate of Registration;

The winning supplier shall – upon claiming of the Contract – present the original copy of the documents listed above for comparison, or submit a **Certified True Copy** of the original document which must be certified by the issuing government agency. However, the **original copy** of the Omnibus Sworn Statement, Price Quotation Form, and Brochure **must be included in the sealed bid.** 

Price quotation/s must be valid for a period of one hundred twenty (120) calendar days from the date of submission.

The quotation shall be submitted in sealed envelope on or before the closing date of APR 2.4 2024 at 10:00 AM, CAAP Procurement Division and addressed to:

Quotations exceeding the Approved Budget for the Contract shall be rejected.

Award of contract shall be made to the lowest quotation, which complies with the minimum description as stated above and other terms and conditions stated in the price quotation form. In case two or, more bidders are determined to have submitted the Lowest Calculated/Lowest Calculated and Responsive Quotation, CAAP-CCC shall adopt and employ "draw lots" as the tie breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.

The CAAP-TIAC shall have the right to inspect and/or test the goods to confirm their conformity to the technical specifications.

Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. CAAP shall rescind the contract once the cumulative amount of liquidated damaged reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

#### SERVICE CHARGE

2. The CONTRACTOR shall make such inspections, adjustments and maintenance as may be required to keep the machines in good working condition and as may be required by the CAAP. Such inspections, adjustments and maintenance shall be free of charge.

#### TERMINATIONS

1. Subject to the procedure prescribed by law, the CAAP may terminate the contract under any of the following conditions:

a. Outside of force majeure, the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract. The CAAP may rescind or terminate the contract and impose appropriate sanctions over and above the liquidated damages to be paid.

b. Upon termination or expiration of the contract, the CAAP shall return the machines and accessories to the CONTRACTOR by allowing the latter, on a date and time agreed upon by both the CAAP and the CONTRACTOR, to enter the CAAP premises for the purpose of retrieving the machines.

# LIQUIDATED DAMAGES

 Failure to comply with the terms and conditions of the contract will result in the payment of corresponding penalties/liquidated damages in the amount to 1/10 of 1% of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches 10% of the amount of the contract, CAAP shall rescind the contract, without prejudice to other courses of action and remedies open to it.
