**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF STEEL
 CABINETS FOR THE YEAR 2024 OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP-ILO 2024-016-01 for the project **Supply and Delivery of Steel Cabinets for the Year 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Thirty Six Thousand Forty Five Pesos (₱ 136,045.00)** hereby form the integral part of this resolution. WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last April 29, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Quotation with the Bid amount of **One Hundred Thirty Five Thousand Eighty Eight Pesos (₱ 135,088.00)**;
