WHEREAS, BAC Resolution No. BSVP-ILO 2024-018-01 for the project **Supply and Delivery of Monoblock Chairs for 2024 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Forty Five Thousand Pesos (₱ 45,000.00)** hereby form the integral part of this resolution.
