RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF ELECTRIC FANS FOR 2024 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-019-01 for the project Supply and Delivery of Electric Fans for 2024 at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Twenty Thousand Nine Hundred Seventy Six Pesos (P 20,976.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last April 29, 2024, NEW ILOILO IZEEM COMMERCIAL SUMMIT INC. was declared Single Calculated Quotation with the Bid amount of Twenty Thousand Seven Hundred Thirty Six Pesos (# 20,736.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
