**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF ELECTRIC
 FANS FOR 2024 AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP-ILO 2024-019-01 for the project **Supply and Delivery of Electric Fans for 2024 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Twenty Thousand Nine Hundred Seventy Six Pesos (₱ 20,976.00)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last April 29, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Quotation with the Bid amount of **Twenty Thousand Seven Hundred Thirty Six Pesos (₱ 20,736.00)**;


