RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF COMPUTER DESKTOP AND LAPTOPS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-020-01 for the project Computer Desktop and Laptops at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Six Hundred Twenty Nine Thousand Five Hundred Pesos (P 629,500.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last May 9, 2024, CYBER LINK COMPU SALES was declared Single Calculated Quotation with the Bid amount of Six Hundred Twenty Eight Thousand Seven Hundred Forty Pesos (P 628,740.00);

WHEREAS, bid submitted by NUNTIUS ELECTRONICS INC. has been disqualified due to non-compliance of the Request for Quotation Terms and Condition Item No. 3: "Bidders must quote for all the items."

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
