Attention is hereby invited to the bidders for the Project: "LEASE OF FLIGHT INSPECTION SYSTEM AND AIRCRAFT FOR CAAP-FICG FLIGHT OPERATIONS MISSION NATIONWIDE 2024 - RADIO NAVIGATIONAL AIDS CHECK (Bid No. 24-022-05 "Bravo"), with an ABC of P55,680,000.00, where it is informed that:

- I. The Project Scope is limited to the flight inspection of Radio Navigational Aids and associated conventional instrument flight procedures of the CAAP, based on the CAAP Project Procurement Management Plan 2024 (PPMP 2024) and Corporate Operating Budget (COB 2024) APPROVED by the CAAP BOARD. Other flight inspection activities shall be procured upon approval by the CAAP Board of the funds for such purposes.
- II. The Instruction to Bidders (ITB) Section 5.3 is amended to specify that a prospective bidder must have completed a Single Largest Completed Contract (SLCC), similar to the contract to be bid, at a value of at least fifty percent (50%) of the ABC;
- III. The following SAMPLE FORMS have been APPENDED in this Bid Bulletin No. 01 dated 17 May 2024 for project BID NO. 24-022- 05 BRAVO, for the reference of the bidders:
