- Mayor's or Business Permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas;
- 2. Income Business Tax Return for ABC's above ₱500,000.00;
- 3. PHILGEPS Certificate of Registration;
- 4. Tax Clearance;
- Notarize Omnibus Sworn Statement (GPPB prescribed Form) for ABC's above ₱50,000.00;

However, the **original copy** of the Omnibus Sworn Statement, Price Quotation Form, and Brochure **must be included in the sealed bid.**

Price quotation/s must be valid for a period of one hundred twenty (120) calendar days from the date of submission.

Quotations exceeding the Approved Budget for the Contract shall be rejected.

Award of contract shall be made to the lowest quotation, which complies with the minimum description as stated above and other terms and conditions stated in the price quotation form. In case two or, more bidders are determined to have submitted the Lowest Calculated/Lowest Calculated and Responsive Quotation, CAAP-CCC shall adopt and employ "draw lots" as the tie breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.

The CAAP-TIAC shall have the right to inspect and/or test the goods to confirm their conformity to the technical specifications.

Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. CAAP shall rescind the contract once the cumulative amount of liquidated damaged reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

SCOPE OF WORK

- 1. Supply and delivery of Mechanical Seal Kit, Motor and pump Bearings, and other consumables for the preventive maintenance of three sets of 20HP-Paco Chilled Water Pumps at Manila CNS/ATM Facility.
- 2. Supply of labor and expertise for the replacement of seals and bearings of 3 sets of Paco chilled water pumps and motors. Include provision of tools and mobilization.
- 3. Include re-aligning of pumps and motors.
- 4. Include testing and commissioning of 3 Paco Pumps after the replacement of seals and bearings.
- 5. Includes remedial measures and recommendations if an additional defects (not included in the preventive maintenance job) be detected during the course of maintenance.

Warranty: One (1) year warranty from date of acceptance.
