RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF ESPRESSO II CARD PRINTER OF CSIS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BDC-ILO 2024-002-01 for the project Supply and Delivery of Espresso II Card Printer of CSIS at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Seventy Nine Thousand Nine Hundred Fifty Pesos (\$\mathbb{P}79,950.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, One (1) Request for Quotations (RFQ) was forwarded to exclusive supplier;

WHEREAS, Acknowledgement Receipt is attached as proof that copy of Request for Quotation (RFQ) was distributed;

WHEREAS, exclusive supplier submitted their quotation;

WHEREAS, during the Bid Opening last April 5, 2024, AZITSOROG INC., was declared Single Calculated Bid with the Bid amount of Seventy Nine Thousand Nine Hundred Pesos (\$\mathbb{P}79,900.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

WHEREAS, AZITSOROG INC., offered a trade-in discount Thirty Thousand Nine Hundred Fifty Pesos (\$\mathbb{P}\$30,950.00) and resulted to the Bid amount of Forty Eight Thousand Nine Hundred Fifty Pesos (\$\mathbb{P}\$48,950.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, AZITSOROG INC., was found to be the Single Calculated Responsive Quotation;

WHEREAS, implementing the trade-in discount would provide significant cost advantages for Civil Aviation Authority of the Philippines which allow Iloilo International Airport to reduce the total

amount payable from Seventy Nine Thousand Nine Hundred Pesos (\$\mathbb{P}79,900.00)\$ to Forty Eight Thousand Nine Hundred Fifty Pesos (\$\mathbb{P}48,950.00)\$. Which would enable the government to pay less than the actual amount for the specific item or service.

WHEREAS, in Section 34.4 of the 2016 revised IRR of RA No.9184: "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, AZITSOROG INC., as the Supplier with the Single Calculated Responsive Quotation Supply and Delivery of Espresso II Card Printer of CSIS at Iloilo International Airport in the bid amount of Forty Eight Thousand Nine Hundred Fifty Pesos (\$\frac{P}{48}\$,950.00);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
