WHEREAS, BAC Resolution No. BSVP-ILO 2024-023-02 for the project **Repair and Maintenance of Avanza at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Eighteen Thousand One Hundred Twenty Six Pesos & 84/100 (₱ 118,126.84)** hereby form the integral part of this resolution. 
