

## BAC Resolution No. BSVP-ILO 2024-025-02

## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF REPAIR AND MAINTENANCE OF AERIAL WORKING PLATFORM AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-025-01 for the project Repair and Maintenance of Aerial Working Platform at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Fifty Three Thousand Nine Hundred Ninety Nine Pesos & 05/100 (P 253,999.05) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last May 29, 2024, WILAN MERCHANDISING PHILIPPINES INC. was declared Single Calculated Quotation with the Bid amount of Two Hundred Forty Two Thousand Five Pesos (\*P 242,005.00);
