The Civil Aviation Authority of the Philippines, through the APP FY 2024 CAAP Corporate Fund intends to apply the sum TWENTY-NINE MILLION ONE HUNDRED FIFTY-TWO THOUSAND SIX HUNDRED FORTY-THREE AND 81/100 (Php 29,152,643.81) being the Approved Budget for the Contract (ABC) to payments under the contract for REBLOCKING OF RUNWAY AND TAXIWAY AT BUTUAN AIRPORT (Bid No. 24-037-06 ALPHA). - 4. Interested bidders may obtain further information from the Civil Aviation Authority of the Philippines, BAC Office and inspect the Bidding Documents at the address given below from 08:00 AM to 05:00 PM from Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on 20 June 2024 until deadline of submission of bid from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PHP 28,000 (inclusive of 12% VAT). The Procuring Entity shall allow the bidder to present its proof of payment of the fees by presenting the official receipt in person.

- 6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference<sup>1</sup> on **02 July 2024** @ **9:30 AM** through videoconferencing/webcasting via Jitsi/Zoom/Google Meet, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before 16 July 2024 @ 9:30 AM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- Bid opening shall be on 16 July 2024 @ 9:30 AM at the given address below and/or Jitsi/Zoom/Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
