This pertains to the **Competitive Bidding** for the contract **“REPAIR OF ACU AT PTB OF DIAA”** conducted by the **Civil Aviation Authority of the Philippines - Area XI**, the Procuring Entity.

- b. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank - **Five percent (5%) of the Total Price**
- c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security - **Thirty Percent (30%) of the Total Contract Price**

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of **18 DEGREES AIR COOLING SOLUTIONS, INC.** and render this notice canceled.

Furthermore, as you submit the performance security and other documents, please include a transmittal to indicate the receipt date.
