TERMS OF REFERENCE

PURCHASE OF 4 UNITS TIRES OF PASSENGER BOARDING BRIDGE no.3 and 6 at DAVAO INT'L AIRPORT

I. GENERAL CONDITIONS:

1.1. Administrative Requirements:

The Contractor shall comply with the following:

- 1.1.1. Visit and inspect the site to apprise oneself of the actual condition that will affect the implementation of the project to be done. The Contractor shall secure a Certificate of Site Inspection from the Civil Aviation Authority of the Philippines (CAAP).
- 1.1.2. Comply with the security, safety, Davao International Airport house rules, and plans for maintaining continued job site cleanup.
- 1.1.3. Investigation and submission of report/s to **Davao International Airport** for any accident or untoward incident that may occur at the site for the duration of the project.
- 1.1.4. Assume all responsibilities for injuries to persons and damages to **Davao International**Airport and other property caused by the execution of the works and shall be liable for any claims against **Davao**International Airport on account of such injury and/or

1.2. Safety and Sanitation Requirements:

- 1.2.1. Workers engaged in the project shall wear appropriate personal protective equipment.
- 1.2.2. Employees of the Contractor shall wear uniform marked with the Contractor's company name and shall be with valid company I.D. while inside the premises of the **Davao International Airport** premises.
- 1.2.3. All areas disturbed by the implementation of the project shall be thoroughly cleaned to the full satisfaction of the **Davao International Airport**.

1.3. Requirements for Storage of Equipment:

- 1.4.1. All equipment shall be stacked in a stable and self-supporting manner. All sharp objects shall be removed to avoid injury to workers and **Davao International Airport** personnel.
- 1.4.2. Passageways and all access ways shall be kept free from equipment and material obstructions at all times.

1. The Contractor shall, within seven (07) calendar days after issuance of Notice to Proceed submit to the CAAP for approval of the brands of the Passenger Boarding Bridge Tires and other accessories to be supplied including all its installation and a list of materials (with description and specifications) proposed to be used in the project. All accessories to be installed without prior approval of CAAP shall be at the risk of rejection.

- 2. The project shall be completed within <u>Sixty (60) calendar days</u> from the effectivity date indicated in the Notice to Proceed.

- 4. All works must be done without disruption on the working condition of the working areas.
