AEROMEDICAL ADVISORY NO. 02-2024

SUBJECT: VALIDITY OF ROUTINE TEST REQUIREMENTS SUBMITTED FOR VARIOUS CLASSES OF AVIATION MEDICAL CERTIFICATES.

This Advisory is issued to inform all holders of Aviation Medical Certificates issued by the Authority pursuant to Philippine Civil Aviation Regulation (PCAR) Part 2.10 on the application for issuance of Initial, Renewal and Re-certification for various Classes of Aviation Medical Certificates.

As a Department of the Flight Standards Inspectorate Service (FSIS), the Office of the Flight Surgeon and Aviation Medicine (OFSAM) has been undergoing process review and improvement in preparation for ISO 9001:2015 Certification on Quality Management System (QMS) which included the various processes of the aeromedical certification.

As part of its review and improvement, kindly be informed of the revised validity of various Routine Test Requirements acceptable to the Authority, and shall be effective immediately:

1	Complete Blood Test (CBC)	30 days
2	Urinalysis	30 days
3	Blood Chemistry	60 days
4	Electrocardiogram (ECG)	60 days
5	Chest Radiography	60 days
6	Treadmill Stress Test	60 days
7	Puretone Audiometry	90 days
8	Drug Test	12 months*




