**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND
 RECOMMENDING APPROVAL OF FOOD PROVISION IN RELATION TO BASIC
 AERODROME RESCUE AND FIRE FIGHTING (ARFF) TRAINING COURSE AT ILOILO
 INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP-ILO 2024-027-01 for the project **Food Provision in Relation to Basic Aerodrome Rescue and Fire Fighting (ARFF) Training Course at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Eighty Eight Thousand Pesos (₱ 288,000.00)** hereby form the integral part of this resolution. WHEREAS, during the Bid Opening last June 18, 2024, **MAMBA BAR AND RESTAURANT** was declared Single Calculated Quotation with the Bid amount of **Two Hundred Eighty Eight Thousand Pesos (₱ 288,000.00)**;
