RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF REPAIR AND MAINTENANCE OF MITSUBISHI STRADA AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-035-02 for the project **Repair and Maintenance of Mitsubishi Strada at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Eighty One Thousand Five Hundred Ninety Three Pesos & 67/100 (₱ 181, 593.67)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last July 19, 2024, **CASTLE ROO CAR SERVICES** was declared Lowest Calculated Quotation with the Bid amount of **One Hundred Seventy Seven Thousand Five Hundred Ten Pesos (₱ 177, 510.00)**;
