



**BAC Resolution No. BSVP-ILO 2024-038-02**

**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF IT SUPPLIES FOR THE MONTH OF JUNE TO SEPTEMBER 2024 OF ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP-ILO 2024-038-01 for the project **Supply and Delivery of IT Supplies for the month of June to September 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Twenty Two Thousand Eight Hundred Fifty Five Pesos (₱ 222,855.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, Three (3) interested suppliers submitted its sealed quotation;

**WHEREAS**, during the Bid Opening last July 9, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Quotation with the Bid amount of **One Hundred Eighty Thousand Seventy Four Pesos (₱180, 074.00)**;

**WHEREAS**, bid submitted by:

- a) **SYNERGYTRUMP TRADING** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:
  1. Omnibus Sworn Statement and
  2. Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative


