Quotations exceeding the Approved Budget for the Contract shall be rejected.

Award of contract shall be made to the lowest quotation, which complies with the minimum description as stated above and other terms and conditions stated in the price quotation form. In case two or, more bidders are determined to have submitted the Lowest Calculated/Lowest Calculated and Responsive Quotation, CAAP-CCC shall adopt and employ "draw lots" as the tie breaking method to finally determine the single winning provider in accordance with GPPB Circular 06-2005.

The CAAP-TIAC shall have the right to inspect and/or test the goods to confirm their conformity to the technical specifications.

Any interlineations, erasures or overwriting shall be valid only if they are signed or initialed by the bidder or his/her duly authorized representative/s.

Liquidated damages equivalent to one tenth of one percent (0.1%) of the value of the goods not delivered within the prescribed delivery period shall be imposed per day of delay. CAAP shall rescind the contract once the cumulative amount of liquidated damaged reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.

## **General Requirements:**

- 1. The contract price is inclusive of all duties and taxes.
- 2. No changes shall be made on the Contract Price by reason of escalation in currency. Any adjustment in Contract Price shall be done in accordance with guidelines provided by law.
- 3. The project duration covering the Preventive Maintenance Service and Calibration of Treadmill Machine in CAAP shall be for a period of one year
- 4. Exact dates of delivery and/or completion should be reckoned from the date of CONTRACTOR's receipt of Notice to Proceed/Notice of compliance.
- 5. The CONTRACTOR must be competent and experienced in the field of Maintenance Service and Calibration of Treadmill Machines with a minimum of three (3) years prior experience on similar projects.

- 6. The CONTRACTOR is required to submit a company profile, list of present and previous clientele, and certifications issued by past/present clients indicating the Contractor's satisfactory performance.
- 7. The CONTRACTOR shall provide Preventive Maintenance Service and Calibration of Treadmill Machines and will perform the full program for the Preventive Maintenance Service (PMS) for 1 year starting from initial PMS, and will be performed quarterly during standard business hours.
- 8. The CONTRACTOR shall perform Onsite Labor Coverage and provide on-site service support. Support is provided during standard business hours for issues that cannot be resolved by telephone or through remote support.
- 9. The CONTRACTOR will provide unlimited remote technical support by e-mail, fax and remote service during standard business hours.
- 10. The CONTRACTOR shall observe the maximum response time of within four (4) hours from the time the CAAP makes its request for on-site services during regular working days. In case of prolonged or recurring mechanical failure on the unit/s and/or unserviceable within 24 hours or one day from the time of notice, the CONTRACTOR must provide replacement unit/s.

#### SERVICE CHARGE

- 1. Total Contract Price: PHP 100,000.00
- 2. The CONTRACTOR shall make such inspections, adjustments and maintenance as may be required to keep the machines in good working condition and as may be required by the CAAP. Such inspections, adjustments and maintenance shall be free of charge.

#### **TERMINATIONS**

- 1. Subject to the procedure prescribed by law, the CAAP may terminate the contract under any of the following conditions:
- a. Outside of force majeure, the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract. The CAAP may rescind or terminate the contract and impose appropriate sanctions over and above the liquidated damages to be paid.
- b. Upon termination or expiration of the contract, the CAAP shall return the machines and accessories to the CONTRACTOR by allowing the latter, on a date and time agreed upon by both the CAAP and the CONTRACTOR, to enter the CAAP premises for the purpose of retrieving the machines.

### LIQUIDATED DAMAGES

Failure to comply with the terms and conditions of the contract will result in the payment of
corresponding penalties/liquidated damages in the amount to 1/10 of 1% of the cost of the unperformed
portion for every day of delay. Once the cumulative amount of liquidated damages reaches 10% of the
amount of the contract, CAAP shall rescind the contract, without prejudice to other courses of action
and remedies open to it.
