The Civil Aviation Authority of the Philippines, Area Center V, Bicol International Airport now invites bids for the TRANSFER AND COMMISSIONING OF 300 KVA DEGS FROM OLD LEGAZPI AIRPORT TO VIRAC AIRPORT-2nd PUBLIC BIDDING. Completion of the Works is required within Sixty (60) Calendar Days. Bidders should have completed, within the last five (5) years, a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index. For this purpose, similar contract refers to Installation of Electrical Feeder Lines or Installation and Commissioning of Generator Sets. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 5. Prospective Bidders may obtain further information from Civil Aviation Authority of the Philippines, Area Center V, at its physical address at the BAC Office, G/F Admin Building, Bicol International Airport, Daraga, Albay, and inspect the Bidding Documents from 8:00AM to 5:00PM, Monday to Friday.






