WHEREAS, BAC Resolution No. BSVP-ILO 2024-031-02 for the project **Installation of Baby Seats in all Restrooms of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Fifty Nine Thousand Six Hundred Thirty Eight Pesos & 51/100 (₱ 159,638.51)** hereby form the integral part of this resolution.
