RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF DRUGS & MEDICINES, MEDICAL & DENTAL SUPPLIES FOR 2024 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-040-01 for the project **Supply and Delivery of Drugs & Medicines, Medical & Dental Supplies for 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Fifty One Thousand One Hundred Thirty Six Pesos & 82/100 (₱ 151,136.82)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last July 22, 2024, **ECGA MEDICAL EQUIPMENT AND SUPPLIES TRADING** was declared Single Calculated Quotation with the Bid amount of **One Hundred Fifty One Thousand One Hundred Thirteen Pesos & 60/100 (₱151, 113.60)**;
