RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF BRUSH CUTTER BLADE AND STEEL PILE AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-045-01 for the project **Supply and Delivery of Brush Cutter Blade and Steel Pile at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Twenty Thousand Four Hundred Forty Pesos (₱ 20,440.00)** hereby form the integral part of this resolution. 
