Under Section II. Instructions to Bidders Clause 10.1	
10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in Section VIII (Checklist of Technical and Financial Documents).	In addition to the Technical Documents specified in Section VIII (Checklist of Technical and Financial Documents), the Contractor/Bidder shall submit the following:  1. Valid PCAB license with Category "C" in General Engineering as Principal Classification and Registration Particular "Small B" for Navigational Facilities.  2. Certificate of Site Inspection signed by the ANS

- Facility-in-Charge of Kalibo International Airport or his duly authorized representative.
- 3. List of contractor's major equipment units for the project such as Boring Machine with corresponding core bits, AGL Installation Jigs, Concrete Cutters, etc. which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project.

Bids not complying with the above instructions shall be DISQUALIFIED.

Under Section VII. Technical Specifications

Statement of Compliance

[Bidders must state here either "Comply" or "Not Comply" against each of the individual parameters of each Specification stating the corresponding performance parameter of the equipment offered. Statements of "Comply" or "Not Comply" must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection. A statement either in the Bidder's statement of compliance or

Statement of compliance shall be required for all the items except for the following:

- 11. 2 nos- Handhole
- 14. 5 cu. m Sand bedding
- 15. 15 cu. m Excavation
- 16. 10 cu. m Backfilling

the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the applicable laws and issuances.]
