## BAC Resolution No. 2024-0212-105 (Bravo)

## SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF 1-YEAR SUBSCRIPTION OF CAAP CORPORATE EMAIL SERVICES WITH 1000 ACCOUNTS

**WHEREAS**, the project, Supply, Delivery, Installation and Commissioning of 1-year Subscription of CAAP Corporate E-Mail Services with 1000 Accounts, an ODG-MISD CORPLAN project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Seven Million Three Hundred Thousand Pesos (Php7,300,000.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) 2024-04-484 dated 17 April 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 24 April 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 06 May 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C*";

**WHEREAS**, the Pre-bid Conference was conducted on 15 May 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 29 May 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively;*

**WHEREAS**, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 05 June 2024 and was presented to the BAC on the same day, where it is indicated that the tendered bid proposal of ePLDT Inc. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H"*, *respectively;* 

**WHEREAS**, the Committee issued a letter to ePLDT Incorporated., dated 11 June 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "I"*;

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 26 June 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **ePLDT Incorporated** be **Post-Disqualified** for having an ongoing projects with more than negative 15% slippage and for the Joint Venture of **Radenta** and **Maroon Studios** to undergo Post-Qualification Process for being the Next Lowest Calculated Responsive Bid (LCRB) for the project **Procurement of 1-Year Subscription of CAAP Corporate E-mail Services with 1000 Accounts**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively.;* 

**WHEREAS**, the Committee sent a letter of Post-Disqualification to ePLDT dated 26 June 2024. A copy of the notice of Post Disqualification is hereto attached as *Annex "L"*.;

**WHEREAS**, the Committee received a Request for Reconsideration from ePLDT dated 27 June 2024. A copy of the Request for Reconsideration is hereto attached as *Annex "M"*;

**WHEREAS**, during the BAC Bravo regular meeting conducted on 08 July 2024, the BAC TWG- Bravo presented their answer to the Request for Reconsideration of ePLDT and recommended the approval of the said reconsideration. A copy of the Minutes of the Meeting is hereto attached as *Annex "N"*;

WHEREAS, the BAC TWG (Bravo) in a discussion dated 10 July 2024 recommended the bid proposal of ePLDT Incorporated be declared as the Lowest Calculated Bid (LCB) in the amount of Five Million Six Hundred Thousand Pesos (Php5,600,000.00) for the project Procurement of 1-Year Subscription of CAAP Corporate E-mail Services with 1000 Accounts.

**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend* to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the *post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Supply, Delivery, Installation and Commissioning of 1-year Subscription of CAAP Corporate E-Mail Services with 1000 Accounts in the amount of to Five Million Six Hundred Thousand Pesos (Php5,600,000.00) to ePLDT Incorporated.
