



*BAC Resolution No. 2024-0212-104 (Bravo)*

**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROVISION OF SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF 500 MBPS DEDICATED LEASED-LINE SERVICE FOR CAAP MAIN OFFICE**

**WHEREAS**, the project, Supply, Delivery, Installation and Commissioning of 500 MBPS Dedicated Leased-Line Service for CAAP Main Office, an ODG-MISD CORPLAN project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Three Million Six Hundred Thousand Pesos (Php3,600,000.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) 2024-02-263 dated 31 January 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 24 April 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 08 May 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, the Pre-bid Conference was conducted on 17 May 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 29 May 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 05 June 2024 and was presented to the BAC on the same day, where it is indicated that the tendered bid proposal of PLDT Inc. undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "G" & "H", respectively;

**WHEREAS**, the Committee issued a letter to PLDT Inc., dated 11 June 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "I";

**WHEREAS**, the BAC TWG (Bravo) issued its Post-Qualification Report dated 26 June 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **PLDT Inc.** to be declared as the Lowest Calculated Responsive Bid (LCRB) in the amount of **One Million Pesos (Php 1,000,000.00)** for the project **Supply, Delivery, Installation and Commissioning of 500 MBPS Dedicated Leased-Line Service for CAAP Main Office**. The copy of said Report and Minutes of Meeting are hereto attached as Annexes "J" & "K", respectively.;



**NOW THEREFORE**, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Supply, Delivery, Installation and Commissioning of 500 MBPS Dedicated Leased-Line Service for CAAP Main Office in the amount of to **One Million Pesos (Php1,000,000.00)** to **PLDT Inc.**






