



*BAC Resolution No. 2024-0212-87 (Alpha)*

**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF IMPROVEMENT OF TOILETS AT CAAP MAIN BUILDING (Bid No. 24-028-05 Alpha)**

**WHEREAS**, the project, Procurement of Improvement of Toilets at CAAP Main Building, an ADMS project was forwarded to the Bids and Awards Committee – Alpha of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Six Million Nine Hundred Twenty-Three Thousand Three Hundred Sixteen Pesos & 92/100 (PHP6,923,316.92). A copy of the Certificate of Budget Allocation CBA (MOOE) No. 24-01-044 dated 17 January 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 07 May 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 16 May 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 28 May 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and opening of bids for the project was held on 11 June 2024 at the CAAP Conference Room and via video conference. Bidders submitted their bid proposals for the project, and the following results were noted. A copy of the Minutes of the Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F"*, respectively;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (BAC-TWG) issued its Bid Evaluation Report dated 18 June 2024 and was presented to the BAC on the same day, where it is indicated that the bid proposal of D&D Engineering Services, Co. be disqualified for tendering an incomplete bid due to non-conformity with the Bill of Quantities of the BDS, and for WDC Builders & Supplies to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H"*, respectively;





**WHEREAS**, the Committee issued a letter to WDC Builders & Supplies dated 18 June 2024 requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as *Annex "I"*;

**WHEREAS**, a Notice of Disqualification letter was sent to D&D Engineering Services, Co. dated 25 June 2024. A copy of the said letter is hereto attached as *Annex "J"*;

**WHEREAS**, the BAC TWG (Alpha) issued its Post-Qualification Report dated 25 June 2024 and was presented to the BAC on the same day, wherein the BAC TWG (Alpha) recommended that the bid proposal of **WDC Builders & Supplies** be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **SIX MILLION THREE HUNDRED EIGHTY THOUSAND SIX HUNDRED FIFTY-EIGHT PESOS & 13/100 (PHP6,380,658.13)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "K" & "L", respectively*;

**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

**NOW, THEREFORE**, premises considered, the **CAAP-BAC (ALPHA) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Procurement of Improvement of Toilets at CAAP Main Building in the total amount of Six Million Three Hundred Eighty Thousand Six Hundred Fifty-Eight Pesos & 13/100 (**PHP6,380,658.13**) to WDC Builders & Supplies.
