



*BAC Resolution No. 2024-0212-112 (BRAVO)*

**SUBJECT: RECOMMENDING THE AWARD OF BIDDING FOR THE PROJECT SUPPLY AND DELIVERY OF 500 SETS OF CONFERENCE KIT FOR 59<sup>th</sup> DGCA**

**WHEREAS**, the project, Supply and Delivery of 500 sets of Conference Kit for 59th DGCA was forwarded to Civil Aviation Authority of the Philippines Bids and Awards Committee-Bravo (CAAP BAC-Bravo) for its procurement. The project has an approved budget of One Million Six Hundred Thousand (1,600,000.00). A copy of the Certificate Budget of Allocation (CBA (MOOE) No. 24-05-687 dated 29 May 2024) is herein attached as *Annex A*;

**WHEREAS**, the Pre-procurement Conference was conducted on 03 June 2024, where the details pertaining to this procurement was discussed and clarified. A copy of the Minutes of the Meeting is hereto attached as *Annex B*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 10 June 2024, in the PhilGEPS and CAAP website and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex C*;

**WHEREAS**, the Pre-bid Conference was conducted on 19 June 2024, via in-person meeting and Google Meet Video Conference. A Copy of the Minutes hereto attached as *Annex D*;

**WHEREAS**, on 03 July 2024, the Submission and Opening was conducted. A lone bidder submitted its bid proposal, upon inspection and evaluation of the eligibility requirements submitted, it was determined that Kaifashion Philippines Inc., failed to submit a Certificate of no pending case against the Government and was declared disqualified. A Copy of the Minutes of the Meeting and Abstract of Bids as Read hereto attached as *Annex E & F*;

**WHEREAS**, on 04 July 2024, Kaifashion Philippines Inc., submitted a Request for Reconsideration citing that the submitted bid was complete and compliant with all the requirements and asked to review and open their bid proposal. **WHEREAS**, on 05 July 2024, the CAAP-BAC Bravo granted the Request for Reconsideration and scheduled the re-opening of bids. A copy of the Minutes of the Meeting is hereto attached as *Annex H*;

**WHEREAS**, on 08 July 2024, the Re-Opening of bid was conducted, the submitted proposal was determined by the BAC TWG. The compliance with the documents required to be submitted for eligibility and for the technical requirements was evaluated as passed. A Copy of the Minutes of the Meeting and Abstract of Bids as Read hereto attached as *Annexes I & J*;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 09 July 2024 and was presented to the BAC on 10 July 2024, where it is indicated that the tendered bid proposal of Kaifashion Philippines Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. 
**WHEREAS**, the Committee issued a letter to Kaifashion Philippines Inc., dated 10 July 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "M"*;

**WHEREAS**, the BAC TWG (Bravo) issued its Post-Qualification Report dated 18 July 2024 and presented it to the BAC Committee (Bravo) on 19 July 2024, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Kaifashion Philippines Inc.** be declared as the Single Calculated and Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **One Million Five Hundred Twenty-Seven Thousand Five Hundred Pesos Only (Php1,527,500.00)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "N" & "O", respectively*;







