



CCC Resolution No. 2024-034

SUBJECT: **PREVENTIVE MAINTENANCE SERVICE AND CALIBRATION OF COMPUTED RADIOGRAPHY SYSTEM.**

WHEREAS, Purchase Request/POW/CBA No. 24-02-0161 dated 8 February 2024 for the Preventive Maintenance Service and Calibration of Computer Radiography System with a total budget of P100,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 26 February 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement; employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. Copy of the minutes hereto attached as **Annex B**;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 3 April 2024, no quotation was received by the CCC Secretariat. The project was posted for the second time on 19 April 2024, two (2) quotations were received by the Secretariat but were disqualified due to non compliance in the technical specifications and documentary requirements. The project was posted for the third time on 07 May 2024, no quotation was received by the Secretariat. The project was re-posted on 21 May 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

1. MEDEV MEDICAL DEVICES CORPORATION;
2. WIRED MED;
3. COLENT MEDICAL & GRAPHIC INC.;
4. OMNIBUS BIO-MEDICAL SYSTEM, INC.; and
5. ASSURANCE CONTROLS TECHNOLOGIES;

WHEREAS, during the opening of the sealed RFQs held on 24 May 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

Supplier	Price Quotation
1. WIREDMEDITEK CORP.	P95,000.00

WHEREAS, the end-user evaluation report submitted on 4 June 2024 disclosed that WIREDMEDITEK CORP. complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "*Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation.*"


NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Preventive Maintenance Service and Calibration of Computed Radiography System in the total amount of NINETY FIVE THOUSAND PESOS (P95,000.00) only, and be AWARDED to WIREDMEDITEK CORP., the offer of which was considered reasonable and advantageous to the Government;
