



BAC Resolution No. 2024-0212-98 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PREVENTIVE MAINTENANCE SERVICE AND CALIBRATION OF LABORATORY EQUIPMENT/MACHINES (1 YEAR) SELECTRA PRO- S BLOOD CHEMISTRY AND SWELAB ALFA PLUS (HEMATOLOGY ANALYZER)

WHEREAS, the project, Preventive Maintenance Service and Calibration of Laboratory Equipment/Machines (1 Year) Selectra Pro-S Blood Chemistry and SWELAB Alfa Plus (Hematology Analyzer), an FSIS-OFSAM project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Two Hundred Nineteen Thousand Pesos (Php 219,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-04-0529 dated 24 April 2024 is herein attached as *Annex "A"*;

WHEREAS, the Change/Determination of Mode was conducted on 20 May 2024 where the end-user requested for the Change of Mode of Procurement from Competitive Bidding to Direct Contracting stating the fact that there is only one service provider for the project a position substantiated by the submitted Apostille Certificate of Sole Distributorship which the Committee, after reviewing the documents concurred. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Request for Quotation to Biocare Health Resources Inc. on 24 June 2024 for the Notice for Direct Contracting. A copy of the notice is hereto attached as *Annex "C"*;

WHEREAS, the Submission and Opening of bids for the project was held on 01 July 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "D" & "E", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 08 July 2024. On the same date, the BAC-Bravo TWG presented its report indicating that Biocare Health Resources Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "F" & "G", respectively*;



WHEREAS, Section 50 of RA 9184 it provides that Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:


Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Preventive Maintenance Service and Calibration of Laboratory Equipment/Machines (1 Year) Selectra Pro-S Blood Chemistry and SWELAB Alfa Plus (Hematology Analyzer)** in the total amount of **Two Hundred Ten Thousand Pesos (Php 210,000.00)** to **Biocare Health Resources Inc;**
