



*BAC Resolution No. 2024-0212-139 (Bravo)*

**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF CAAP CENTRAL OFFICE SERVICE VEHICLE (4 VEHICLES)**

**WHEREAS**, the project, Procurement of CAAP Central Office Service Vehicle (4 Vehicles), an FMD-Motorpool project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Seven Million Two Hundred Thousand Pesos (Php7,200,000.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) 2024-06-751 dated 13 June 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 14 June 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 21 June 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, Bid Bulletin No. 01 dated 01 July 2024 was issued for the schedule of the Opening and Submission of Bids on 17 July 2024. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "D"*;

**WHEREAS**, the Pre-bid Conference was conducted on 03 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "E"*;

**WHEREAS**, Bid Bulletin No. 02 dated 16 July 2024 was issued for the re-scheduling of the Opening and Submission of Bids to 24 July 2024 and for some clarification/revision/amendments in the bidding documents of the project. A copy of the Bid Bulletin 02 is hereto attached as *Annex "F"*;

**WHEREAS**, Bid Bulletin No. 03 dated 24 July 2024 was issued for re-scheduling of the Opening and Submission of Bids to 31 July 2024. A copy of the Bid Bulletin No. 03 is hereto attached as *Annex "G"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 31 July 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "H" & "I", respectively*;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 31 July 2024 and was presented to the BAC on 09 August 2024, where it is indicated that the tendered bid proposal of Toyota Quezon Ave Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (LCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

**WHEREAS**, the Committee issued a letter to Toyota Quezon Ave Inc., dated 09 August 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "L"*;

**WHEREAS**, the BAC TWG (Bravo) issued its Post-Qualification Report dated 12 August 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Toyota Quezon Ave Inc.** to be declared as the Single Calculated Responsive Bid (SCRB) in the amount of **Seven Million One Hundred Sixty Thousand Pesos (Php7,160,000.00)** for the project **Procurement of CAAP Central Office Service Vehicle (4 Vehicles)**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "M" & "N", respectively*;

**WHEREAS**, the BAC TWG-Bravo recommended for the award of the project **Toyota Quezon Ave Inc.**, in the amount of **Seven Million One Hundred Sixty Thousand Pesos (Php7,160,000.00)**.


**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

**NOW THEREFORE**, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Procurement of CAAP Central Office Service Vehicle (4 Vehicles) in the amount of **Seven Million One Hundred Sixty Thousand Pesos (Php7,160,000.00)** to **Toyota Quezon Ave Inc.**


