The Civil Aviation Authority of the Philippines (CAAP) through its Bids and Awards Committee intends to apply the sum of **Fourteen Million Eight Hundred Sixty-Two Thousand Four Hundred Seventy-Three Pesos and 92/100 (Php14,862,473.92)** inclusive of all applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) to payments under the contract for the project, **PROCUREMENT OF SPARE PARTS FOR VSAT COMMUNICATIONS SYSTEM UNDER THE CNS/ATM**
