



CCC Resolution No. 2024-011

SUBJECT: PURCHASE OF MATERIALS FOR THE REPLACEMENT OF DEFECTIVE TOILETS/URINALS FLUSHOMETERS SENSOR ASSEMBLY/SOLENOID AT SELECTED MALE AND FEMALE COMFORT ROOMS AT ATMC BUILDING.

WHEREAS, Purchase Request/POW/CBA No. 24-03-331 dated 06 March 2024 for the Purchase of materials for the replacement of defective toilets/urinals flushometers sensor assembly/solenoid at selected male and female comfort rooms at ATMC Building with a total budget of P220,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 20 March 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". Copy of the minutes hereto attached as Annex B;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 21 March 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 03 April 2024, Copy of PhilGeps postings hereto attached as Annex C;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

WHEREAS, during the opening of the sealed quotations held on 08 April 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

WHEREAS, the end-user evaluation report submitted on 23 April 2024 disclosed that Boston Builder's Center. complied with all CAAP requirements and specifications and is considered as the lowest calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex D.

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Purchase of materials for the replacement of defective toilets/urinals flushometers sensor assembly/solenoid at selected male and female comfort rooms at ATMC Building. in the total amount of ONE HUNDRED SEVENTY-NINE THOUSAND SIX HUNDRED FIFTY PESOS (P179,650.00) only, and be AWARDED to Boston Builder's Center, the offer of which was considered reasonable and advantageous to the Government;
