



CCC Resolution No. 2024-029

SUBJECT: PURCHASE OF VARIOUS REFRIGERANT FOR THE USE IN PREVENTIVE MAINTENANCE OF AIR-CONDITIONING UNIT AT CAAP CENTRAL OFFICE.

WHEREAS, Purchase Request/POW/CBA No. 24-04-517 dated 23 April 2024 for the Purchase of various Refrigerant for the use in Preventive Maintenance of Air-Conditioning unit at CAAP Central Office with a total budget of P90,250.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 10 May 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *“Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex “H” of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR”*. WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 14 May 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

1. *CLEANGREEN SOLUTIONS*;
2. *JRM REFRIGERATION & AIR CONDITIONING SERVICES*;
3. *COOLWORLD AIRCONDITIONING AND CONSTRUCTION INC.*;
4. *ROSE AIRE ENTERPRISE INC.*; and
5. *TRUE-TEMP CORPORATION*;

WHEREAS, during the opening of the sealed RFQs held on 17 May 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

1. TRUE-TEMP CORPORATION	P90,000.00

WHEREAS, the end-user evaluation report submitted on 24 May 2024 disclosed that True-Temp Corporation complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**:

WHEREAS, Annex “H” of the Revised IRR of RA 9184, states, “*Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation.*”

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Purchase of various Refrigerant for the use in Preventive Maintenance of Air-Conditioning unit at CAAP Central Office in the total amount of **NINETY THOUSAND PESOS (P90,000.00)** only, and be **AWARDED** to **True-Temp Corporation** the offer of which was considered reasonable and advantageous to the Government;
