RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR THE MONTH OF JUNE TO SEPTEMBER 2024 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. SHOPPING (B)-ILO 2024-001-01 for the project **Supply and Delivery of Office Supplies for the month of June to September 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Twenty Five Thousand Five Hundred Seventy Pesos & 50/100 (P 225,570.50)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Two (2) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last July 29, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Lowest Calculated Quotation with the Bid amount of **One Hundred Sixty Five Thousand Two Hundred Thirty One Pesos (P165, 231.00);**
