

CCC Resolution No. 2024-017

SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF TWO (2) UNITS 2HP WALL MOUNTED SPLIT-TYPE AIR SUBJECT: CONDITIONING UNITS.

WHEREAS, Purchase Request/POW/CBA No. 24-02-253 dated 20 February 2024 for the Supply, Delivery, Installation and Commissioning of Two (2) units 2HP Wall Mounted Split-Type Air Conditioning Units with a total budget of P139,464.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 08 April 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 19 April 2024, Copy of PhilGeps postings hereto attached as Annex C;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply, Delivery, Installation and Commissioning of Two (2) units 2HP Wall Mounted Split-Type Air Conditioning Units in the total amount of ONE HUNDRED TWENTY-FOUR THOUSAND FIVE HUNDRED TWENTY-EIGHT PESOS (P124,528.00) only, and be AWARDED to Beemax Consumer Goods Trading, the offer of which was considered reasonable and advantageous to the Government;
